# (b) Access to the footbridge over the river which flows down from Mynydd Mallaen

This was brought to the attention of the Community Council by Mr Arwel Evans who had attended the meeting and explained his concerns. An email had been sent to Mr Jason Lawday, PROW, explaining the issues regarding the ford, the footbridge, whose responsibility, etc. He advised that "there is evidence for a dedication by the previous owner and acceptance by the public it would be possible to register the bridge/path under common law 'deemed dedication' via a Definitive Map Modification Order. This was discussed at length and it was agreed to proceed with this proposal.

As soon as a response is received from PROW the Clerk to email everyone and not wait until the next meeting. This was proposed by Councillor M. Paul and seconded by Councillor J. Pickup.

## (c) Footpath 8/10

The Clerk had contacted Mr Jason Lawday, who stated that there were no updates, he has attempted to contact the landowners, but they have not replied. There is the possibility of moving the path away from the riverbank but this would require landowner's consent. In the meantime, the erosion is continuing, and it is difficult to say when it might stop. As members of the Community Council knew the landowners, the Clerk to ask for a list of names and also what information was required.
