Except for the matters reported below in my Basis for the Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return.

Basis for Qualification

Accounting Statement

In my opinion the Accounting Statement does not properly present the Council's receipts and payments for the year:

Line 6 excludes an upresented cheque (000709) issued in November 2022 for £150. Line 6 is understated by £150.00 and lines 7, 9 and 11 are overstated by £150.00.

The Council's minutes record receipt of £1,050 in donations during the year. However, the cashbook and the accounting statement record only £900.00.

Annual Governance Statement

I am unable to conclude whether or not the Annual Governance Statement is consistent with the Council's governance arrangements:

Assertion 2 – The Council states that it has maintained an adequate system of internal control. However:

My audit testing identified discrepancies between the Council's recorded arrangements for making payments and the way in which payments are recorded and reported to the Council.

9 (k) Bute Energy and Solar wind farm - Nant yr arst and Ty Llwyd

The proposed Pylon Scheme by Bute Energy was discussed at length, the possibility of placing overhead pylons throughout the Tywi Valley. Also included in the discussion was the future and way forward with Solar wind farms. Renewable energy was discussed and the effects of wind farms/pylons to owners of private land. Public Meetings had been held at Llandovery and Llandeilo. Bute Energy are organizing public consultations regarding their forthcoming community engagement proposals, there are meetings in Llandeilo on the 25th of March and Llandovery on the 29th of March.
