Minutes of the meeting of Cilycwm Community Council held on Tuesday 7th November, 2023 at 7.30 p.m. at Capel y Groes.

Mr. Arwel Evans had requested to attend the meeting regarding the access to the footbridge over the river which flows down from Mynydd Mallaen. A detailed explanation had been received from Mr Jason Lawday, copies had been given to everyone and the reply read out in the meeting. The legality of this has now been called into question, and NRW will be checking their documents to see if they have powers to grant permissive access to the public along the forest track and bridge. They do not own the land in question, but they have their own private access rights which may or may not allow them to grant permission access. The Community Council could make a formal application but before Jason Lawday can take this forward, he needs to follow up with Arwel and Mark and NRW regarding their private rights. There may be the potential to resolve the issues through negotiation and this would be a lot easier than going through the Modification Order process.

All these elements are being analysed in depth within the service review we are undertaking. Your bin requested has been logged."

Audit 2022/2023 report

Audit General's report and audit opinion

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my opinion to give cause for concern that, in any material respect, the information reported in the Annual Return.

- (a) has not been prepared in accordance with proper practices
- (b) that relevant legislative and regulatory requirements have not been met
- (c) is not consistent with the Council's governance arrangements: and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources

Basis of Qualification Accounting Statement

In my opinion the Accounting Statement does not properly/fairly present the Council's receipts and payments/income and expenditure and financial position;

The Council's reported payments exclude two unpresented cheques issued during 2022/2023. Although the cheques were not presented to the bank by 31 March they must be accounted for in 2022-3023. Total payments are therefore understated by £211 and the Councils closing balance are overstated by £211.

Annual Governance Statement

I am unable to conclude whether or not the Annual Governance Statement is consistent with the Council's internal controls and governance arrangements for the year:

(a) The Accounts and Audit (Wales) Regulations require the Council: to maintain an adequate and effective system of internal audit. The internal auditor report did not identify that the accounts had not been properly prepared as noted above. In my opinion, the internal audit was not adequate and effective.

There are no further matters that I wish to draw to the Council's attention.
